Chatham Marconi successfully launched a major new exhibit in 2023, transforming its smaller museum space into a cruise ship gallery as the Golden Age of Trans-Atlantic Ocean Liners. The exhibit highlights historical insights and stories of ocean voyages from the late 1920s through the 1960s, before air travel became practical and convenient. During that era, Chatham Radio/WCC helped keep passengers in contact with family, friends and businesses via ship-to-shore communications.

4b (Code:) (Expenses \$ **141,000** including grants of \$) (Revenue \$)

Significant Community Preservation Act funds were requested from the Town of Chatham, via the Chatham Preservation Committee, to create a new Chatham Marconi archive facility. Town Meeting approved \$142,000 for the project to renovate space on the second floor of the historic Education building to properly accommodate the museum's archives collection. Work was initially funded by Chatham Marconi beginning 7/23 and was completed and fully reimbursed by 12/23. The new archives storage area provides state-of-the-art environmental conditions for the preservation of documents and offers appropriate space for access to materials for use by the public, scholars and researchers.

The Chatham Marconi TechSmart STEM education program brings lessons in communication technology science to local public school fourth grade classrooms. Students also participate in a field trip to the Chatham Marconi campus to visit the museum and engage in hands-on experiments. Designed in 2018, the program was poised for implementation after a successful pilot program in the local school district in 2019. The pandemic intervened, however, and it was shelved until 2022. In 2023 the program saw significant expansion, with CM Tech Smart in 4th grades of 4 local school districts: Chatham Elementary, Dennis Yarmouth, Harwich and Wellfleet.
